• Deliberate and act on Special Appropriation requests:

Meet with representatives of Glocester Senior Center requesting special appropriation for the FY2017 budget relative to their budget requests

The Glocester Senior Center was unable to send a representative to this meeting. This item will be taken up at the meeting of February 18, 2016.

• Deliberate and act on Department CIP Requests

School Department CIP

VOTED to recommend \$90,000 for the Eccelston Field House; that the funds are allocated from the Undesignated Fund of the School Department and that the priority is increased to #1a.

VOTED to allocate the balance of \$399,888 to School Department Capital Improvements.
