 - a) Receive report from administration regarding
 - i) **Year-to-Date Financial Statement**: Motion made by Michael Dutilly and seconded by Kristen Connelly to accept the report as submitted. The motion passed unanimously.
 - ii) **Progress on proposed third BEC site**: Director Kelly Cournoyer informed the Board that both the Town Council and the School Committee support the plans for opening a third BEC site, to be located at the Austin T. Levy Elementary School. The BEC staff will conduct a trial at the Levy School on June 3-4 and, pending approval of a license by the Department of Children, Youth, and their Families, the Levy School site would open in September 2019.
 - iii) **Progress on security concerns at Steere Farm Elementary School**: Director Cournoyer met with members of the Burrillville School Safety Task Force. They recommended several modifications in the BEC area at the school, among which is the installation of a panic alarm. The estimated cost for these modifications is \$15,000. The BEC Board will review the plans at our next meeting.
 - iv) **Planning for the summer program**: Plans are well under way. We have reached our student capacity on two weekdays, but applications are still being accepted for the remaining weekdays.

- v) **Town adopt-a-spot at both BEC site**: The BEC administration has identified a location at Steere Farm Elementary School that staff and students will maintain, and BEC staff members are working with staff at Callahan Elementary School to identify a spot there for the BEC program to adopt.
- b) **Discussion about planning currently underway with the School Department to provide a summer lunch program for students enrolled in the BEC summer program**: According to Director Cournoyer, BEC program staff are currently working on compiling a list of eligible students for a closed lunch program during the summer.
- 7) A motion to adjourn was made by Michael Dutilly and seconded by Kristen Connelly. The meeting adjourned at 6:47 PM.
