December 11, 2020	Municipal/School Departments submit Capital Improvement Budget Requests to Finance
December 28, 2020	Municipal/School Departments submit Operating Budget Requests to Finance
TBD	Joint pre-budget meeting – Town Council, School Committee and Budget Board
February 19, 2021	Budget Board submits Capital Improvement Budget (CIP) recommendation to Town Manager (Target Date – Date required by Ordinance is March 1, 2021 - Ordinance §2-112 -First Monday of March)
March 15, 2021	Manager submits his Capital Improvement Budget (CIP) recommendation to the Town Council
March 17, 2021	Public Notice of the Public Hearing on Capital Improvement Budget (CIP) Program
<b>March 24, 2021</b>	<b>7:00 p.m. Public Hearing – CIP Program</b> <b>Adoption of FYE 2021 CIP Program &amp; update of the 5-Year Plan</b> (Ordinance deadline is April 15, 2021)
April 5, 2021	Budget Board submits FYE 2022 Operating Budget recommendations to Town Manager (Charter Due Date: First Monday in April)
April 21, 2021	Town submits budget data and ads to the State for review and approval.
May 3, 2021	Manager submits his Operating Budget recommendations to the Town Council (Charter Due Date: First Monday in May)
May 10, 2021	Last Date that three (3) ads need to appear advising the public of the proposed budget, proposed tax changes, and dates of public hearings. The final ad needs to appear at least ten (10) days before the first public hearing.
<b>May 20, 2021</b>	<b>7:00 p.m. 1st Public Hearing – Municipal Budget</b> <b>Town Council Chambers</b>
<b>May 27, 2021</b>	<b>7:00 p.m. 2nd Public Hearing – School Budget</b> <b>Town Council Chambers</b>
<b>June 3, 2021</b>	<b>7:00 p.m. - Additional Public Hearing Date (if necessary)</b> <b>Town Council Chambers</b>
<b>June 9, 2021</b>	<b>7:00 p.m. - Budget Adoption (1st Council Meeting in June)</b>
<b>June 23, 2021</b>	<b>7:00 p.m. - Final Budget Adjustments (if necessary)</b> <b>(2nd Council Meeting in June)</b>
July 1, 2021	New Fiscal Year begins

June 1	Deadline for notice of reduction in Teaching Workforce
<b>Charter References</b>	
April (First Monday)	Latest date Budget Board shall submit its recommendations to the Manager
May (First Monday)	Latest date Manager shall submit its recommendations to the Town Council
June (First Monday)	Latest date that two (2) Public Hearings must be held.
Budget Adoption	Council Adopts Budget No later than June 15th
Line Item Veto	Manager may veto any item within seventy-two hours.
	Council may override the veto by affirmative vote of four (4) members
Voter Initiative	Referendum on changes to department budgets may be held upon the petition of fifteen percent (15%) of the voters.
