Information Systems:

VOTED to allocate a total of \$210,917 for Information Systems.

Tax Assessor:

VOTED to reduce Tax Assessor professional/technical services to \$2,000.

VOTED to allocate a total of \$137,915 to the Tax Assessor's Office.

Board of Assessment Review:

VOTED to not fund postage, office supplies or miscellaneous for the Assessment Board of Review.

VOTED to fund a total of \$1,300 for the Assessment Board of Review.

Motion by Dennis Anderson. Seconded by Nathan St. Pierre. The vote was unanimous by the five members present.

Planning:

VOTED to reduce office supplies from \$800 to \$300 for Planning.

Motion by Judy Aubin. Seconded by Dennis Anderson. The vote was unanimous by the five members present.

VOTED to fund a total of \$135,182 for Planning.

Motion by Nathan St. Pierre. Seconded by Judy Aubin. The vote was unanimous by the five members present.

VOTED to support \$12,800 for the Planning Board.

Motion by Judy Aubin. Seconded by Robert Tetreault. The vote was unanimous by the five members present.

Building Official:

VOTED to reduce Building Official's gas/diesel line item to \$2,000.

VOTED to grant a total of \$129,491 to the Building Department.

Zoning Board:

VOTED to reduce Zoning Board office supplies to \$500.

Motion by Judy Aubin. Seconded by Nathan St. Pierre. The motion carried, four in favor, one opposed. Voting in favor of the motion were Arthur Hurley, Judy Aubin, Nathan St. Pierre and Robert Tetreault. Dennis Anderson voted in opposition.

VOTED to fund the Zoning Board for a total of \$17,601.

Motion by Judy Aubin. Seconded by Robert Tetreault. The vote was unanimous by the five members present.

General Services:

MOTION to fund the Board of Administration at \$125,000 with the reasoning that the remaining funds are to come from their cash on hand.

Motion by Judy Aubin. Seconded by Robert Tetreault. No vote was taken.

There was discussion of the requested increase in rent by the Board of Administration. It was noted that the Board of Administration's current assets exceed \$300,000 and a reason for the rent increase is not explained in the budget request. It was also noted that the Board of Administration has not provided additional financial information that was requested by the Budget Board.

The clerk was instructed to send a letter to the Board inquiring: 1) what their current cash balance is and 2) the purpose of maintaining a cash balance at the current level.

Miscellaneous:

VOTED to reduce dues and fees to \$6500.

Motion by Judy Aubin. Seconded by Nathan St. Pierre. The vote was unanimous by the five members present.

VOTED to recommend \$7,000 for public utilities.

Motion by Dennis Anderson. Seconded by Judy Aubin. The vote was unanimous by the five members present.

VOTED to grant a total of \$13,500 for Miscellaneous.

Motion by Dennis Anderson. Seconded by Judy Aubin. The vote was unanimous by the five members present.
