Overview of the American Rescue Plan Act of 2021 including input collection, scheduling and timetables, and the eligible uses including but not limited to the following categories:

- **Broadband** - Invest in broadband infrastructure with modern utility in mind. Broadband efforts should aim to improve reliability, accessibility and affordability of internet.
- **Community Grants** - Assist organizations (non-profit) that serve the needs of vulnerable populations within the community, particularly those heavily impacted by the pandemic. Investments can range from assisting individuals to supporting redevelopment within neighborhoods.
- **Economic Development** - Provide aid to small businesses and industries negatively impacted by COVID-19 and its effects on the local economy.
- **Outreach and planning to the local business community.**
- **Organizational Needs** - Address needs within Town departments or amongst essential employees that improve the capabilities of staff to respond to public needs and support employees most susceptible to COVID.
- **Tourism/Travel Industry** - Speed the recovery of tourism, travel, and hospitality sectors.
- **Utility Infrastructure** - Make necessary improvements to water and sewer infrastructures. Utility investments should aim at improving the reliability and resiliency of the utility system.
- **Eligible non-profit proposals.**
- **Other eligible uses** as outlined by the US Department of Treasury.
