
Burrillville Town Council Resolution In opposition to Senate Bill S-2891 An Act Relating to Public Officers and Employees Federal Old-Age and Survivors Insurance

- WHEREAS, Senate Bill S-2891 would amend Section 37-7-6 of the General Laws in Chapter 36-7 entitled "Federal Old Age and Survivors' Insurance"; and
- WHEREAS, the amendment covers the group that includes all employees of the school district of a municipality; and
- WHEREAS, the municipalities of the state shall subscribe to the federal state agreement as set forth in § 36 7-3 for the purpose of extending benefits of title II of the federal Social Security Act, 42 U.S.C. § 401 et seq.; and
- WHEREAS, this act would now require municipalities to ensure that school district employees are eligible for social security benefits under title II of the federal Social Security Act, 42 U.S.C. § 401 et seq.; and
- WHEREAS, the cost to the Town of Burrillville would be \$997,772 in the first year, and the annual cost would increase each year; and
- WHEREAS, the Rhode Island Senate Bill S-2891 will create an unprecedented unfunded mandate, and would cause financial hardship; and
- WHEREAS, the Rhode Island tax cap, which has allowed cities and towns to manage municipal real estate taxes, would be effectively neutralized; and
- WHEREAS, the Town of Burrillville, in the strongest terms, rejects the implementation of S-2891; and

NOW THEREFORE BE IT RESOLVED that the Town of Burrillville respectfully requests that the Burrillville delegation and all of the General Assembly membership reject Senate Bill S-2891 as an excessive unfunded mandate being imposed on the cities and towns of the State of Rhode Island.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to every Rhode Island municipality and Burrillville's legislators requesting they support us in opposition to this legislation.

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 36-7-6 of the General Laws in Chapter 36-7 entitled "Federal Old-

36-7-6. Subscription to agreement by city, town, or state agency.

(a) For a coverage group that includes all employees of the school district of a municipality,

5 the municipalities of the state shall subscribe to the federal state agreement as set forth in § 36-7-3

6 for the purpose of extending benefits of title II of the federal Social Security Act, 42 U.S.C. § 401

9 (b) For all employees not covered pursuant to subsection (a) of this section, Any any city, town, or agency of the state as defined in § 36-7-2(2) shall have the option of subscribing to the 10 11 federal state agreement as described in § 36-7-3. The action shall be taken by the adoption of an 12 ordinance, resolution, or vote by the legislative body thereof which shall be the city council in the 13 case of a city, or a financial town meeting in the case of a town, or the board of directors, authority, 14 commissioners, trustees, or other governing body in the case of an agency of the state. The 15 resolution, ordinance, or vote shall indicate its intention of extending the benefits of title II of the 16 federal Social Security Act, 42 U.S.C. § 401 et seq., in conformity with the provisions of that act, 17 to employees of the city, town, or agency of the state as a coverage group, as herein defined. The

18 resolution, ordinance, or vote, to be acceptable, must contain at least the following provisions,

1 requirements, and conditions:

2 (1) To meet fully the requirements of the federal Social Security Act, 42 U.S.C. § 301 et seq., and be in accord with the provisions of the federal state agreement herein provided; 3 (2) To provide that all services which constitute employment as herein defined and are 4 5 performed in the employ of the city or town or agency of the state by employees thereof, shall be 6 included in the designated coverage group; 7 (3) To specify the source or sources from which funds necessary to make contributions in 8 the amounts and at the rates specified in the federal state agreement, are expected to be derived, 9 and contain reasonable assurance that those sources will at all times be adequate to meet this 10 obligation; (4) To provide for such methods of administration of its plan of participation under the 11 12 agreement as will insure the proper and effective operation thereof; 13 (5) To provide that the city, town, or agency of the state will make such reports, in such 14 form and containing such information as may be prescribed from time to time by the general 15 treasurer in accordance with directives or regulations of the secretary, and that the city, town, or 16 agency of the state will at all times comply with such other rules or regulations as the general 17 treasurer or the administrator may from time to time prescribe to assure the correctness and 18 verification of the reports. 19 SECTION 2. This act shall take effect upon passage.
