## BURRILLVILLE TOWN COUNCIL RESOLUTION ESTABLISHING A TOWN RESTRICTED FUND

The Finance Director is hereby authorized to establish a Town Restricted Fund (The Fund) for the use of the Municipal Departments for fiscal year ending June 30, 2019.

- (1) Purpose: The Fund is established in the amount of \$603,329 to allow Municipal Departments to fund specific activities that are not annually recurring and not funded in the Town's operating budget.
- (2) Funding: The Town Restricted Fund will be financed as follows:
  - a. Transfer of \$193,600 from fund 3800, Health Care Contingency
  - b. Transfer of \$225,229 from fund 3880, Debt Reduction
  - c. Appropriation of funds totaling \$184,500 from the Unassigned Fund Balance (Unreserved Undesignated General Fund Balance)
     Note: Pursuant to Sec. 3.14(J) of the Burrillville Town Charter, The appropriation of money from the unreserved, undesignated fund balance of the general fund shall
  - require the affirmative vote of six (6) members of the Town Council.

    Disbursement: Money shall be disbursed from the Fund upon receipt by the Treasurer's
- Office of properly documented vouchers to the extent that monies are available in the Fund.
  - a. Transfers from fund 3800 Health Care Contingency
    - \$50,000 to fund the Town's Police Department Accreditation Stipend expenses
    - \$15,000 to fund the Town's Legal /Professional Services for costs related Council
       94 and FOP contract negotiations
    - \$15,000 to fund National Grid/Enbridge appraisal services
    - \$25,000 to fund the Town's substance abuse programs and outreach
    - \$5,000 to fund oversight of the Town's Substance Abuse Programs
    - \$45,000 to fund contingencies that may arise during the FYE June 30, 2019
    - \$10,000 to fund account 0100128-531200(Audit) for expenses incurred to comply with State mandated Transparency Portal set up
    - \$5,400 to fund account 0100116-514300 (Details) once the budgeted amount of \$2,700 has been exceeded

- \$21,000 to fund account 0100116-515500 (Election Workers) once the budgeted amount of \$7,000 has been exceeded
- \$2,200 to fund account 0100116-534200 (Postage) once the budgeted amount of \$4,000 has been exceeded
- b. \$225,229 transfer from fund 3880, Debt Reduction, to fund payment of the Town's loan from the Industrial Foundation due May 20, 2019
- c. Appropriations from the Unassigned Fund Balance
  - \$5,000 to fund improvements to the Binns Building (Berard-Desjarlais Post 88)
  - \$7,500 to fund the Town's Unemployment expenses as needed after line 0100113-529500 has been exhausted
  - \$150,000 to assist in School Department out-of-district line items once the amount budgeted for out-of-district tuition (Accts 55610, 55630, 55640, and 55660 \$1,594,031) has been exceeded
  - \$22,000 to assist in School Department Fuel costs once the amount budgeted for Fuel has been exceeded
- (4) <u>Unexpended Funds</u>: All funds not expended from The Fund shall lapse and be returned to the original source fund.
- Operating Procedures: The Finance Director or his designee may establish procedures to (5)govern the operation of The Fund.
- Expiration Date: The Town Restricted Fund authorization will expire June 30, 2019, unless (6) extended by resolution of the Town Council.
